00533. Reports from Groups

Recreation, Play, Youth and Halls

Cllr HC provided an update and said that she has chased Stuart Brown from Mid Sussex District Council via email for an update regarding progress with the playground? Cllrs MS spoke about the Balcombe Parish Council website, and suggested trialling Google Analytics at a cost of £20 to try to draw attention to the Hire of Bramble Hall and Pavilion.

Neighbourhood Plan

The deadline for approval of the S106 document between MSDC for Shanly Homes/The Rectory Site has expired (24/5/22); and in addition, there has not been any further update with regards to the village car park.

Cllr As offered to provide an update to the Councillors at the next meeting about the Areas of outstanding natural beauty (AONBs) in relation to the Center Parcs development.

Planning and New Development

No further updates.

Transport

A meeting took place last week with the members of the transport working group. Contractor Enerveo are to produce a lighting plan for the Zebra Crossing for the Centre of the Village. A meeting is to be arranged with Richard Speller from West Sussex County Council (WSCC) to discuss a way forward regarding the road surfacing for the centre of the village.

Energy

Cllr Sue Taylor provided an update regarding the work she has been doing to obtain the correct Alexon codes in order to ensure Balcombe Parish Council is being charged correctly for the Street Light usage based on the type of bulb. Communication continues between Enerveo, UK Power Networks and Southern Electric. Enerveo have been asked to provide a quotation for the London Road with intention to replace all non LED bulbs with LEDS.

Admin and Assurance

Charlotte to look into possible external IT support for councillors using Microsoft 365

00534. The enhancement of the village centre project: To approve the expenditure of £1295.51 plus VAT for the P3 design of a lighting column for the Zebra crossing on the Haywards Heath Road.

Resolved to approve.

00535. To Review Terms of Reference of membership of the working groups

Cllr NG had agreed Terms of Reference for the Transport working group but Cllr AS suggested an extension until September's meeting to give time for all groups to review membership and terms of reference.

00536. Financial

June's Cash book Receipts and Payments.

Payments cashed included: Balcombe Primary School grant £4184.80, Integra insurance (Bramble Hall) £708.79, Victoria Cripps (internal Audit) £400, Parochial Church Council – Friends of Ukraine grant £1000, Pitch Hire (MSDC) £1444.20.

00537. To consider yearly fixed amount grant to the Victory Hall.

Balcombe Parish Council's intention is to continue to grant the Victory Hall an amount at the current level of £4500. The guidelines state that the grant must be used for a specified project.

00538. <u>Balcombe Village Fete, Saturday 16th July – confirm who will be there, what are we presenting/showing and rota.</u>

It was suggested to try to coordinate the placement of the stalls to include BPC, the Police, and Neighbourhood watch. Cllr NG put forward the need to promote Speedwatch in order to try and sign up residents to the scheme. Rota to be shared and organised.

00539. To confirm if additional insurance cover is required to cover the Fete, and if so to approve costing.

It was agreed to take out additional insurance to cover the Fete, and the additional payment of approx. £140 was agreed.

00540. Center Parcs update.

Cllr AS provided an update and said that a Protect Oldhouse Warren (POW) meeting took place on 6/06/2022. No formal application as of yet. Proposal of Surveys of flora and forna – by ecologists. There are traffic and infrastructure concerns regarding the location of the site and size (553 acres)

00541. Correspondence.

Cllrs SG, AS offered to look through the published DPD site allocations inspectors report and feed back to councillors at the next meeting.

Suggestion to promote the Speedwatch scheme in the parish Magazine.

MSDC Applauds – nominate a Balcombe resident; doesn't have to be a Parish Councillor.
